**ENTRY DEADLINE FOR ALL TEAMS: Monday, October 28, 2019.**

**YOUR SCHEDULING TEAM:** Contacts for all league communication continue to be Margot Maurer and Chris McNally. Our [indoorconcordiaddonau@gmail.com](mailto:indoorconcordiaddonau@gmail.com) email account is the primary method of contact and we monitor this account on a regular basis while leagues are in session. If a situation **genuinely** merits immediate attention we can be reached via the Donauschwaben main office number (440-235-2646), or directly by cell – Margot at 440-454-0766 or Chris at 216-346-6346. Margot and Chris create the schedule, with Chris your primary contact for reschedules. **All communication must include your name, email, phone number, and team name.**

**SESSION COST:** **Entry fee for the 8-week Fall 2019 session is \$426.00 per team.** This fee should be submitted along with registration paperwork. Teams failing to pay the registration fee prior to the fifth week of the session will be permitted play their regularly scheduled matches, but each match completed without payment will reflect a forfeit loss of 4-0 in the league standings, regardless of match outcome. **Teams failing to pay their fee prior to the end of the session will not be permitted to register for subsequent sessions until the fee is paid.** Prompt payment is appreciated.

**REFEREE DEPOSIT:** A standing \$26.00 referee deposit is required of all teams. This fee is collected once, then held by the league in the event of a team no-showing or canceling less than 24 hours prior to a scheduled match. In this case, the referee will be paid using the deposit from the team responsible for the unplayed match. Our referees cannot be expected to go unpaid due to poor team management. **The match in question may be rescheduled, with both teams responsible for their portion of the referee fee for the that match. The \$26.00 deposit accounts for the unplayed match only.** If your team's referee deposit is not used over the course of a session, it will automatically roll over into the next session (or refunded, if your team is not planning to play the next session). Referee fees are \$13.00 per team. Team managers are responsible for paying before the start of each match. Team managers should bring one warm-up ball and one playing ball to each match.

**DIVISIONS:** All leagues and divisions are listed on the registration form with tentative days/times they will be scheduled. **Please review this form carefully and indicate a preferred division.** Once a division is confirmed, it will not be changed and fees will not be refunded. **Players should not be rostered on more than one team in each age group.** Matches will be rescheduled if the facility closes due to weather or other unforeseen events.
