**YOUR SCHEDULING TEAM:** Your point people for communications will continue to be Margot Maurer and Chris McNally. The [indoorconcordiaddonau@gmail.com](mailto:indoorconcordiaddonau@gmail.com) email account is your primary method of contacting us and we will be monitoring the account on a regular basis. If a situation ***genuinely*** merits immediate attention, we can be reached via the main office number at 440-235-2646, or by cell: Margot 440-454-0766; Chris 216-346-6346. Margot and Chris will collaborate on the schedule, with Chris the primary contact for reschedules. **It is important that all communication includes your full name, email, phone number, and team name.**

**The entry fee for the 8-week long session is \$400.00 per team or \$426.00 for a team new to our leagues. This fee should be submitted along with registration paperwork. Teams failing to pay before the fifth week of the session will be permitted to play at their regularly scheduled time, however, for each match completed without payment the standings will reflect a forfeit loss of 4-0 regardless of outcome.**

**A standing \$26.00 referee deposit is required from each team. In the event of a team no-showing or canceling less than 24 hours prior to a scheduled match, the referee will be paid using the deposit from the team responsible for the match being unplayed. Our referees cannot be expected to go unpaid due to poor team management. The match in question may be rescheduled, in which case both teams are responsible for their portion of the referee fee, as always. The \$26.00 deposit accounts for the unplayed match only. If your team's referee deposit is not used over the course of a session, it will automatically roll over into the next session (or refunded, if your team is not planning to play the next session).**

Referee fees are \$10.00 per team for all YOUTH matches and \$13.00 per team for all ADULT (Men's and Coed) matches. Coaches or team managers are responsible for paying the referee before the start of each match. Coaches or team managers should bring ONE (1) warm-up ball and ONE (1) playing ball to each match.

All leagues and divisions are listed on the registration form with tentative days/times they will be scheduled. Please review the form carefully and indicate a preferred division. Once a division is confirmed, it will not be changed and fees will not be refunded. Players should not be rostered on more than one team in each age group. Matches will be rescheduled if the facility is forced to close due to weather or other unforeseen events.
